

A STORY OF DAYS GONE BY PRESENTED BY GARY WALCHER FOREVER, OLLIE'S PHAETON

I met Ollie Smith in 1969 when he approached me and many other early Ford V-8 owners in the San Diego area to start a chapter of the Early Ford V-8 Club of America. The first meeting to discuss the forming of a club was held at Carl Burnett's Antique Automotive on June 18, 1969. Ollie was persuasive about the benefits of the Early Ford V-8 Club, so I joined that night, becoming a Charter Member of the San Diego Regional Group, along with}4 other Early V-8 Ford enthusiasts.

Ollie had a1935 Ford Phaeton at that time and that was his primary driver, It was a very nice car but definitely out of my range as my budget was more in line with coupes and sedans. As time went by Ollie began to acquire more cars and the '35 was driven less and less. When I would see Ollie at club functions the discussion would sometimes get to the '35 and I would tell him "If you ever decide to sell that car let me know." I would mention this from time to time along with inquiries from other V-8 members but the '35 was not for sale. Ollie would smile and tell me along with the others, " If I decide to sell, I'll let you know."

As the years rolled by I forgot about buying the '35 and was busy with other V-8 projects such as a'39, a'34, and another '32. In the fall of 1994, club member, Jim Carnahan called and asked if I knew that Ollie's cars were for sale. Time and Alzheimer's Disease had claimed Ollie's mind and he was now in a rehabilitation facility. His wife, Jean, decided that it was time to sell Ollie's fine collection of early Ford V-8s. I was reluctant to call her at first because of the circumstances but she welcomed my call and asked which of the cars I was interested in. I told her the '35 Phaeton. That was one of the three cars that were still available. The '46 Sportsman and '46 Station Wagon were already sold. I made an appointment and went over to look at the car. It was pretty much as I remembered. I went home and discussed it with my wife and then brought her back to look at it. We decided that we wanted the car and the deal was made.

The car was equipped with a Columbia, adjustable spoke Kelseys, a radio, clock mirror and side curtains. The only real problem I had was a faulty wheel cylinder and a lack of information about the history of the car as well as maintenance items concerning the running gear. Ollie's wife did not have any of this information and she knew that Ollie would not be able to help me either. Ollie's son, Jeff did remember that the 2I-stud engine had been installed sometime between 1963 and 1965.

By a pure stroke of luck the man who had sold the car to Ollie in 1961, called Mrs. Smith and wanted to talk to Ollie about a'37 Ford that he was thinking about buying. He was surprised to hear about Ollie's failing health and that he still had the '35 after all these years. The two men had not talked to each other since 1961. Mrs. Smith gave me the man's name and telephone number. His name was Stuart Molyneux and he lived in the Watsonville area.

I contacted him and told him that I had purchased the '35 and would like to get some additional information about the car. He proceeded to tell me that he had first seen the car in I 95 I or '52 sitting in a trailer park along Highway I 01, south of the Cow palace in the San Francisco Bay area. He said that the car looked pretty sad, the top was rotted and the rear doors would no longer close. He was in the military and on his way to Korea so all he could do was look. When he returned from the war the car was gone but he was able to find out that someone from Los Gatos had purchased the car for parts as he had another'35 he was working on. The price, "\$15.00 and a bottle of whiskey!" Mr. Molyneux was able to locate the car and traded a'32 roadster, valued at \$250.00 for the old'35 Ford.

He took the car home and over the next several years was able to restore it. He said he was amazed to find all of the side curtain hardware behind the back seat. He also relayed the story of being stopped by the police as he drove the Ford home from the upholstery shop. It was beginning to get dark and he had no fenders, consequently no lights! He said that he sold the car to Ollie in 1961 for \$1250.00 and that paid for a room addition and the birth of one of his children. He was somewhat surprised when Ollie along with his son Jeff showed up at his auto shop class ready to purchase the car, but that part of the story comes later.

I told Mr. Molyneux that we were coming up to Santa Rosa for the 1998 Western National Meet. He wanted us to stop by so he could see the phaeton again but he was going to be in Southern California during that time. Luck again played apart in this story. We were with approximately 30 other V-8s on the Jay Harris Tour headed for Santa Rosa. We stopped at King City for gas and a brief rest. I parked the '35 and went into the restroom. When I came out someone said there was a guy looking at my car and saying that it was his. It was Stuart Molyneux and his wife! They had been across the street eating when the cars began to drive in to gas up. He recognized "his car right away. I took a picture of he and his wife in front of the '35 and he agreed to send me some pictures of the car taken almost 40 years ago.

I now had a bit more information about thE car up to 1961 but still wasn't totally satisfied with the time between 1961 and 1994I went to the June 1999 meeting of the San Diego Regional Group We were celebrating our 30n anniversary. Memorabilia, photos and stories of the old days were shared, After the meeting I went home and dug out the club newsletter, "The Ford Fan", from the very early days of the Club. I was reading and reminiscing when I came across the January 13,1971 issue. Each issue featured a club member's car. The following is from that issue:

"1935 FORD V-8 PHAETON Owner: Ollie Smith. Ollie saw a 1935 Ford Phaeton advertised in Motor Trend in 1958 and dismissed it from further consideration because the price of \$750.00 seemed too high at the time. About three years later he again thought of the car and decided to check on it to see if it was still available. All he could remember was that the car was in Watsonville. He wrote to the Watsonville Chamber of Commerce. (To be continued)



How much of a fire risk are electric vehicles?

We look at why EV fires are so hard to extinguish, how fire services are handling it and how to minimize risks





The news coverage of electric car fires and the surrounding discourse as to whether EVs are the cause of major blazes around the world can't be ignored.

As the prominence of EVs on UK roads rapidly grows, more attention is turning to the safety concerns that such new technology presents, especially because car makers, and journalists, politicians and the general public are still getting used to them. while petrol and diesel cars still catch fire (remember the spate of Vauxhall Zafira fires not so long ago?), an EV fire commands a lot more attention.

As the world gets used to this kind of technology and protocols are put in place to safeguard against disasters (for example, ship owners are increasingly being told to protect their vessels against car fires), it's worth getting to grips with the statistics, why these fires command so much attention, how fire crews deal with them and what it means for you.

Electric car fire statistics UK

EV fires aren't a common occurrence. According to Honeywell Safety and Productivity Solutions, 239 fires recorded in the UK from July 2022 to June 2023 were linked to EVs.

While this is an 83% increase year on year, it's important to note the number has increased along with the increasing presence of EVs on our roads. (CONT. ON PG 12)

(CONT. FRM PG 11) Meanwhile, according to Bedfordshire Fire and Rescue Service, some 1898 fires in 2019 were from petrol and diesel vehicles and 54 were from EVs. Another study by the Swedish Civil Contingencies Agency found that EVs are 20 times less likely to catch fire than ICE cars. An additional study by that agency and an American insurer found that just 25 out of 100,000 EVs suffer fire damage. By comparison, 1530 per 100,000 ICE cars experience fire, and hybrid vehicles suffer a much higher risk of 3475 per 100,000.

Why do electric car fires command so much attention?

Electric car fires draw increased attention for many reasons. The technology is new and newsworthy; and they're complex and often heralded by a highly toxic vapour cloud accompanied by a hissing noise and highly directional jets, followed, possibly, by an explosion. Electric car fires are also incredibly difficult to put out. You think it's out, and then it erupts again hours, days or even weeks later. All this considered, it's no wonder people are becoming concerned about electric car fires, not least those who have to put them out.

How fire crews deal with EV fires

Fire services are developing new strategies to deal with electric car fires. Bedfordshire Fire and Rescue Service, for example, has announced that in the aftermath of any incident, road-traffic collision or fire involving an EV, "one of our attending fire engines will follow the recovery vehicle back to the unloading point at their yard to assist with any fires". It also said it has developed a system that enables fire crews to identify what model of EV is involved in an incident and where its battery and isolation switches are.

Experts are divided on how best to tackle an EV fire but, generally, immense quantities of water to cool the battery pack (although this won't prevent fire erupting again), a fire blanket to

suppress the flames and breathing equipment for the firefighters to protect them from the toxic vapor cloud is the standard approach. Either that or simply let the blaze burn itself out.
